2.Method of selection: The selection of candidate to each position is made in accordance with the instructions contained in DOPT OM No. 14034/1/95-Estt(D) dated 4/5/1995 and reiterated vide OM No. 14034/01/2013-Estt(D) dated 3rd October 2013 as mentioned in para 14 of the notification.

3.The selection of candidates is based on the following terms and conditions:-

a)The candidatures of all candidates are **provisional** and selection is subject to fulfillment of all the conditions prescribed in the notification and also as per Recruitment Rules and instructions.

b) Special age relaxation in accordance with instructions contained in DOPT O.M.No. 15012/3/84-Estt(D) dated 12/11/1987 is given in respect of candidate selected at sl 5.

c) The candidates have to produce required testimonials in support of age, educational qualification, in case of SC/ST/OBC candidates, community certificate in the prescribed format issued by the Competent authority applicable in Central Government services (certificates issued in the State Government format will not be considered) when called for by the concerned authorities. The candidatures of those selected candidates who do not produce the required documents/ certificates in the prescribed formats/ who do not fulfill any of the conditions will outrightly be rejected and no correspondence will be entertained in this regard.

d) The appointment of selected candidates is **provisional** and subject to completion of formalities like verification of all records (certificates of educational qualification, community etc) and Medical examination from Competent Medical Officer (CAS) and other verifications prescribed in the rules.

e) The successful selected candidates will be appointed regularly, only on completion of preappointment formalities against the vacancy earmarked.

f) If it is later on found at any stage that any of these candidates was not eligible to appear for field trials/selection under the rules or instructions on the subject or other reasons or in case any mistake is later on found with regards to announcement of the results of any candidate for any reason what so ever, his name will be deleted from the list of successful candidates, as the case may be. The result is also subject to any change in select list of selected candidates for any reason in accordance with the existing rules and instructions on the subject.

4. Other conditions:

a) In case, the selected candidates fail to turn up for certificate verification, notice(Regd/AD) may be given to the candidates concerned informing the proposed action to remove their names from the select list if they fail to respond.

b) Details of candidates refused/expressed unwillingness to accept offer of appointment may be intimated to this office immediately.

c) The interse-seniority of the selected/appointed candidates in the unit may be fixed as per the instructions on fixation of seniority issued from time to time.

d) The selected/appointed candidates should be adjusted in the recruitment/reservation roster against the category to which he belongs.


