#### **NOTIFICATION**

G.S.R. \_\_\_\_\_\_ In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Indian Posts and Telegraphs Department (Hindi Translators Grade-I), Grade-II, Grade-III and Hindi Typists) Recruitment Rules-1983 in so far as they relate to the posts in the Department of Posts, except as respects thins done or omitted to be done before such supersession the president hereby makes the following rules regulating the method of recruitment to the posts of Junior Hindi Translator and Senior Hindi Translator in the Department of Posts, namely:-

#### 1. Short title and commencement:-

- (1) These rules may be called Department of Posts (Junior Hindi Translator and Senior Hindi Translator) Recruitment Rules, 1996.
- (2) They shall come into force on the dates of their publication in the Official Gazette.
- 2. **Number of Posts, classification and scales of pay:-** The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. **Method of recruitment, age limit and other qualifications:-** The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedules.
- 4. **Disqualification:-** No person,
  - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
  - (b) Who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:
  - (c) Provided that the Central Government may if satisfied that such marriages is permissible under the personal law applicable to such

person and the other parts to the marriages and that there are other grades for so doing, exempt any person from the operation of this rules.

- 5. **Power to relax:** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving:-** Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, other Backward classes, and other special categories of persons in accordance with the orders issued by the Central government from time to time in this regard.
